### **Types of Information Collected and How It is Used**

### **Sharing of Personal Information**

These companies may have access to personal information if needed to perform these functions, but they may use this information only to perform those functions and not for any other purpose. We use various accredited third party administrators to process payments, conduct email marketing, and provide web hosting services.

Camp Can Do may collect names and addresses received through off-line donations and keep them in a database for the purposes of acknowledgement and contact information.

Other than as provided in this privacy policy, Camp Can Do does not sell, transfer, share, or disclose personal information to third parties.

Camp Can Do reserves the right to use or disclose any information necessary to satisfy any law, regulation, or legal request, to protect the integrity of our website, to fulfill your requests, or to cooperate in a law enforcement investigation or an investigation on a public safety matter.
